Black or blue PE 80 pipes, size group 2 (75 - 225 mm), SDR 11, 17, 26

PE 100 pipes can be provided with a blue or brown PP external protection layer, a so-called PE Safe Tech or PE-Plus version. PE 100 pipes can be provided with four blue or brown stripes depending on the application.

PE 80 pipes can be black or co-extruded black with a blue outside layer.

Approved raw materials are specified in Annex 1 which is confidential.

The certificate holder above is hereby given permission to use the INSTA-CERT mark on or in connection with products, which fulfil the requirements of the standard or the normative document specified above (what is said in this document about INSTA-CERT mark will also be valid for marks defined in relevant SBC).
